- » Obtained summary judgment on all claims filed by a plaintiff in a lawsuit against a restaurant alleging claims for hostile work environment and retaliation before the U.S. District Court for the District of South Carolina.
- » Obtained summary judgment on all 49 plaintiffs' claims filed in two related lawsuits in the U.S. District Court for the District of South Carolina alleging various state law claims arising from the plaintiffs' terminations following an investigation by the company into employee misconduct. Prevailed a second time when two of the plaintiffs unsuccessfully appealed to the U.S. Court of Appeals for the Fourth Circuit, which affirmed the District Court's decision awarding summary judgment in favor of the company and dismissing plaintiffs' claims.
- » Obtained summary judgment on all claims filed by a plaintiff

against a healthcare provider in a race discrimination and retaliation lawsuit before the U.S. District Court for the District of South Carolina.
